- 1. This petition is to be used when a person obligated to pay child support has received notice of Delinquency and Intent to Suspend his or her driver=s license. The notice usually comes from the Department of Revenue but may be from another agency or attorney. Service of this notice is permitted by mail. The Notice can also be sent if you have ignored a subpoena, order to appear, order to show cause, or other similar child support enforcement order which has not been complied with.
- 2. THIS IS A TIME SENSITIVE PETITION. You have 20 days from receipt of this notice to comply with it. If you are unable to comply within that time frame, the suspension will proceed, unless you file a petition to contest.
- 3. The statute requires a quick hearing on your petition. The Judge will set the hearing within 15 days after the petition is filed.
- 4. The statute also requires that a copy of the petition be sent to the Clerk of Court, the Department of Revenue, and the depository, if there is one.
- 5. The timely filing of a petition to contest stays the Notice of Delinquency and Intent to Suspend until the entry of a court order resolving the matter.
