New Recording Requirements

Documents Affecting Ownership of Real Property Must Include:

Preparer's Name & Address

- Name of the person who prepared the item or their supervisor's name
- This must be a person; it cannot be a business
- The preparer's address, physical or Po box
- both items must be legibly printed, typed, or stamped on the document

Witness's Name & Address

- Witness's name beneath their signature
- Witness's address, physical or po box
- both items must be legibly printed,
 typed, or stamped on the document

Mental Health Awareness Month

OUR OFFICE PROCESSES BAKER AND MARCHMAN ACT PETITIONS

The Baker Act is a process set forth by the Florida Statutes Mental Health Act in which an individual poses a threat to themselves or others due to their current mental state, and therefore can be admitted to a mental health facility for an involuntary examination.

The Marchman Act is a process in which an individual may be admitted to an involuntary examination due to substance abuse which may impair their judgment and ability to practice self-control.

Baker Act and Marchman Act records are confidential.
