**PLEA TO INFRACTION UPON  
MANDATORY APPEARANCE**

I hereby waive the right to have an Infraction Hearing at which time it would be the obligation of the officer who issued this citation to prove my guilt beyond a reasonable doubt, I would have the right to cross-examine all witnesses, present evidence on my behalf, and to appeal any finding of guilt. This plea is made freely and voluntarily without any force, pressure, coercion or promise of any kind.

This plea may result in sanctions against my driving privilege pursuant to the laws of the state which issued my driver license, which may include suspension. The County Court Judge of Jefferson County, Florida has made no promise of any kind regarding any such action.
