## JEFFERSON COUNTY BOARD OF COUNTY COMMISSIONERS REGULAR SESSION June 3, 2010

The Board met this date in Regular Session. Present were Chairman Danny Monroe, Commissioners Hines Boyd, Stephen Fulford, Eugene Hall and Felix "Skeet" Joyner, County Coordinator Roy Schleicher, Clerk of Court Kirk Reams, and County Attorney Buck Bird.

- Citizen Gordon Dean announced the Watermelon Festival Kick-Off Dinner for Friday, June 4<sup>th</sup> at the Opera House from 5 - 7 p.m.
- On motion by Commissioner Fulford, seconded by Commissioner Hall and unanimously carried, the consent agenda consisting of the minutes from the May 20th regular session was approved.
- 3. Commissioner Boyd stated his concerns about the Commissioner not seeing the bid documents before they were sent to contractors for bids. Sutton Webb with Riley Palmer Construction assured the Commissioner that no decisions would be made without the Commissioner's approval and that the bids were coming in today and would be tabulated for the Board's review. Commissioner Joyner stated the Board was not obligated to spend any money at this time and that if the bids came in and the Board was not happy, they could change the scope of work. He also stated to let the process work itself out and rely on the experts. Commissioner Boyd responded that the process was the problem with the Board not being involved in assisting the development of the bid packages. Commissioner Joyner recommended a workshop to review the bids, which was set for 9:00 a.m. on June 10<sup>th</sup> at the Jefferson County Courthouse Annex.
- 4. County Coordinator Roy Schleicher presented a letter to the Board from Jefferson Communities Water System asking to accept the work for Phase II. Mr. Schleicher recommended only acknowledging the letter from the engineer that accepts the work performed by the Jefferson Communities Water System.
- 5. Clerk of Court Kirk Reams presented a tentative budget schedule for fiscal year 2010-2011. Commissioner Boyd asked for two budget submittals, one under normal circumstances and another which a 5-7 % reduction. He also stated that hard decisions would have to be made in regards to reducing services versus adjusting the millage rate to maintain present service levels.
- 6. County Coordinator Roy Schleicher announced that Attorney Rob Sniffen was not presently ready to address the update of the personnel policy.
- Citizen Santa Hokanson expressed concern that maps advertised were difficult to discern where zoning changes were being made.
- 8. Planning Official Bill Tellefsen informed the Board that a property owner wanted to donate approximately 7.5 acres of primarily wetlands near Interstate-10 and Highway 19 to Jefferson County. It was the consensus of the Board that there was no interest in accepting the donation.
- Commissioner Fulford announced Agriculture Day at Green Industries on Saturday, June 5<sup>th</sup>.
- 10. The warrant register was reviewed and bills ordered paid.

# JEFFERSON COUNTY FFY 2009 and FFY 2010 COMMUNITY DEVELOPMENT BLOCK GRANT FIRST PUBLIC HEARING June 17, 2010 6:00pm

## Purpose of the Hearing

- Two public hearings are required to ensure the public can voice opinions on the proposed application.
- This hearing is held to outline the type of grants which are possible; the second hearing is held to review the draft application before it is submitted to DCA.

## **CDBG Program Objectives**

- Benefit low and moderate income persons (a minimum of 51%)
- · Aid in the prevention or elimination of slums or blight
- Other community development needs

## Regular Categories And Activities

A local government <u>may have only one of these grants open</u> at any given time. There is a set deadline each year, usually in the spring.

- Housing Rehabilitation Assists low and moderate income residents with physical improvements that address code, safety and other rehabilitation items. In some cases, severely damaged structures may be demolished and replaced.
- Neighborhood Revitalization Assists communities with infrastructure improvements, such as paving, fire protection, drinking water, sewer, flood and drainage, handicap accessibility in public facilities, and other similar activities. It is required that no less than 51% of the residents who benefit from these activities be low to moderate income.
- Commercial Revitalization Provides funds to address improvements to downtown or commercial districts, including water, sewer, sidewalks, parking, building facades, etc.

## **Economic Development Category**

A local government can open one new economic development grant every year and there is no limit to the number of these grants which can be open at any given time, provided all grants are on schedule. A local government may apply for an economic development grant even if it has an open housing, neighborhood, or commercial grant, provided that grant is on schedule. There is no deadline – funds are awarded on a first come/first serve basis.

These funds are used to build infrastructure necessary to attract new businesses or retain expanding businesses. *Job creation is required*, and at least 51% of the jobs created must be available to low to moderate income persons. (Low to moderate income jobs are defined as positions requiring no more than a high school diploma. If additional training is required, the company must provide this training at no cost to the employee.)


- 1. Ownership and Evidence of Title: That your applicant is the owner of said real property as described hereinabove. Attached as Exhibit "A". A copy of a portion of the plat showing land ownership and location of the road to vacated. Attached as Exhibit "B".
- 2. <u>Highway Statement:</u> This petition does not include a portion of any State and/or Federal Highway System and was not acquired or dedicated for State or Federal highway purposes.
- 3. <u>Evidence of Taxes:</u> The Petitioner states that all taxes on the Petitioner's lands are paid and current and attached as Exhibit C is evidence of current tax status.
- 4. <u>Municipal Properties:</u> No portion of the road to be vacated is located within municipal corporate limits.
- 5. <u>Fees:</u> The application fee has been paid pursuant Section 9.12 of the Development Code.
- 6. Access to affected Property: That the vacating of the road for public access as herein requested to be vacated, will not adversely affect any other property owner and is not needed by the public as a road or thoroughfare; that there is no present need, nor any future need for said road to be opened and used for public purposes. There are two property owners at the South terminal end of Malloy Landing Road, who will retain their access rights to their property along said road. Petitioners do not seek to affect or interfere with their access rights to their land. These property owners consent to this closing. The Petitioner agrees to grant them a written easement along the "Malloy Landing Road" to their property.
  - 7. <u>Justification:</u> The Petitioner needs for this road to be vacated in order to protect

and secure its property.

8. Notice: That as required by law, your applicant will cause to be published in the MONTICELLO NEWS, a newspaper published in said County, and of general circulation, a NOTICE OF INTENT TO VACATE TO THE BOARD OF COUNTY COMMISSIONERS, JEFFERSON COUNTY, FLORIDA, for the vacation of the portion of said road sought to be vacated which NOTICE shall be published once at least two (2) weeks prior to the hearing to be scheduled by the Jefferson County Board of County Commissioners pursuant to Section 336.10, Florida Statutes. A proof of publication shall be filed with the County Clerk's office prior to the scheduled hearing on said vacation of the above-referenced property.

## JEFFERSON COUNTY, FLORIDA

AN ORDINANCE OF JEFFERSON COUNTY CREATING A NEW CHAPTER\_\_\_PROHIBITING THE COMMERCIAL NON-SALE DISTRIBUTION OF TOBACCO PRODUCTS.

#### LEGISLATIVE INTENT:

WHEREAS, the purpose of this Chapter is to prohibit the free or commercial non-sale distribution of any and all forms of free tobacco products in the furtherance of the goals of promotion of health, safety, and welfare of the residents of the COUNTY OF JEFFERSON, FLORIDA; and

WHEREAS, tobacco companies and affiliates distribute free commercial product samples for the purpose of attracting new tobacco users; and

WHEREAS, the BOARD OF COUNTY COMMISSIONERS OF JEFFERSON COUNTY finds that such tobacco product promotions encourage tobacco use by vulnerable populations and can contribute to adverse health consequences among all populations; and

WHEREAS, tobacco related illnesses are the nation's leading cause of preventable deaths and chronic disease; and

WHEREAS, there is no safe level or form of tobacco use; and

WHEREAS, tobacco is highly carcinogenic and addictive with over 250 toxic Components and over 60 known carcinogens; and

WHEREAS, the Centers for Disease Control recommends policies against easy access to tobacco products to thwart the problem of tobacco; and

WHEREAS, tobacco companies and affiliates distribute samples free and or without cost for the purpose of attracting new tobacco users; and

WHEREAS, tobacco use is harmful to the individual and also to the community with significant social and economic costs; and

WHEREAS, the Board of County Commissioners of Jefferson County hereby finds that this ordinance pertains to and is in furtherance of the health, safety, and welfare of the residents of the County of Jefferson.

## NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF JEFFERSON COUNTY, FLORIDA:

Section 1, A new Chapter Prohibiting the Commercial Distribution of Free Tobacco Products is hereby created to read as follows:
CHAPTER
PROHIBITION OF COMMERCIAL DISTRIBUTION OF FREE CIGARETTES AND TOBACCO PRODUCTS

## DEFINITIONS:

The following words, terms, and phrases when used in this chapter shall have the following meanings ascribed to them in interpreting this Chapter:

- a.) "Cigarette" means (1) any roll of tobacco wrapped in paper or in any substance not containing tobacco; and (2) any roll of tobacco wrapped in any substance containing tobacco which, because of its appearance, the type of tobacco used in the filler, or its packaging and labeling, is intended to be offered to, or purchased by consumers as a cigarette.
- b.) "Commercial" means business or enterprise for profit.
- c.) "Coupon" means anything that can be exchanged for, or used to acquire, a free cigarette or tobacco product, such as a printed piece of paper, voucher ticket rebate, rebated offer check, credit, token, code, password, or anything labeled "coupon" or "coupon offer."
- d.) "Non-Sale Commercial Distribution" means the commercial distribution of cigarettes, tobacco products, or tobacco coupons, by any tobacco manufacturer, wholesaler, or retailer, or any person agent or employee representing tobacco manufacturers, wholesalers, or retailers, without cost or expense to the recipient.
- e.) "Person" means any natural person, partnership, cooperative, association, corporation, personal representative, receiver, trustee, assignee, or any other business entity.
- f.) "Public Place" means any place within the jurisdictional limits of the County publicly or privately owned that is open to the public regardless of any fee or age requirement, including, but not limited to, bars, restaurants, clubs, stores, stadiums, parks, playgrounds, sidewalks, taxis, and buses; and means any place used by a membership association or club at which non-member guests are present or permitted, including for example, fraternity and sorority houses.
- g.) "Tobacco Product" means:

- (1) any substance containing tobacco leaf, including but not limited to cigars, pipe tobacco, hookah tobacco, snuff, chewing tobacco, dipping tobacco, bidis, snus, or any other preparation of tobacco other than a cigarette; and product or formulation of matter containing biologically active nicotine that is manufactured, sold, offered for sale, or otherwise distributed with the expectation that the product or matter will be introduced into the human body other than:
  - (i) a cigarette; or
  - (ii) any product specifically approved by the United States Food and Drug Administration for use in treating nicotine or tobacco product dependence;
  - (2) any product that is promoted to be smoked or used as tobacco including, but not limited to, herbal shisha for hookah pipes.

## PROHIBITION OF COMMERCIAL NON-SALE DISTRIBUTION OF CIGARETTES AND TOBACCO PRODUCTS

- (a) No person including, but not limited to, tobacco manufacturers, wholesalers, retailers, or any agent or employee representing said manufacturer, wholesaler, or retailer shall engage in the non-sale commercial distribution of any cigarette, tobacco product, or coupon.
- (b) No person shall permit the Commercial Non-Sale Distribution of any cigarette, tobacco product, or coupon:
  - (1) any where in any public place under the legal control of the person; or
  - (2) through any agent or employee of the person.
